**Payment:** Cash or checks only. Credit/debit cards accepted with a small fee.

**Age:** All archers must be at least 9 years old.

**Join USA Archery prior to turning in KAC membership application:** **KAC will not accept or hold KAC membership applications without proof of USA Archery membership.** Please include a copy of your card with your application. If applying in person, a digital card may be shown as proof of USA-A membership. *See below for more information*

**Waivers:** The USA Archery waiver, Kennesaw Archery waiver and communicable disease waiver are valid for one year or expiration date noted on waivers. Each individual or family member must complete the waivers prior using the range.

**Youth Archers:** **For your child's safety, a parent or adult guardian (18 years or older) must be present anytime a youth is at the range.** If a minor has driven to the field, they do not need a parent or guardian present. There is no exception to this safety rule!

**Parents & Guardians:** **Parents and guardians must remain behind the waiting line or in the pavilion at ALL TIMES.** Parents and guardians may not walk to the target with their child or coach their child during range sessions. Allow your child to maintain their own scorecard – this is an important skill that each archer must learn for competitions and awards. If non-archer siblings attend, they must remain in the pavilion and be supervised at all times.

**Orientation:** Orientation must be taken before archers can shoot in the regular sessions or before becoming KAC members. Class size will depend on coach availability. Check the calendar on our website for available orientation days. The registration link for the orientation sign-up will open 7 days prior to the event. Participants will be required to purchase personal equipment.

**KAC Membership AND USA Archery Membership:** Please note that USA Archery membership and KAC Membership are separate memberships. A USA Archery membership is required, a KAC membership is not required but is recommended if an archer has their own equipment and wants to use the range other than during session times.

**USA Archery Membership:** USA Archery Membership is required for all recreational archers and KAC members. Go to [www.teamusa.org/USA-Archery/Membership](http://www.teamusa.org/USA-Archery/Membership) to apply. **Please be sure to use an email address and phone number and to affiliate your membership with Kennesaw Archery – please do not provide “junk”, “disposable” or “temporary” email addresses.** Please note that USA Archery membership and KAC Membership are separate memberships.

## USA Archery Membership Levels

### Recreational:

Basic membership level: not eligible to participate in USA Archery sanctioned competitions, Junior Olympic Archery Development (JOAD), and Adult Archery Program (AAP).

### Youth, Adult, Family, Lifetime, AKA “All-Access Memberships”:

An All-Access Membership is required to enter USA Archery sanctioned competitions or to participate in Junior Olympic Archery Development (JOAD) and Adult Archery Program (AAP).

### KAC Recommends a full USA Archery Membership:

We recommend that all archers who think that they might want to join the JOAD or AAP programs or participate in a competition in their first year obtain a full USA Archery membership (Youth, Family, Adult, Lifetime). Recreational members are not eligible to participate in JOAD/AAP or competitions. USA Archery does not have an easy process in place for upgrading memberships.

### Family Membership:

Immediate (or legal guardianship) family members living under the same roof. Please note that each member listed on the Family Membership must complete orientation and be USA Archery members. USA Archery will provide each family member an individual Proof of USA Archery numbers for all family members is required. The KAC and USA Archery waivers must be completed for each family member.

**KAC Membership Benefits:** Members have access to the outdoor ranges 365 days a year from 07:00 AM – 11:00 PM (except for special event days). Members will need to bring their own equipment. Membership benefits do not include the \$5 Saturday morning (outdoor season) range fees \$5 Sunday afternoon (indoor season) range fees or equipment rental fees. JOAD & AAP, camps, classes, training, tournaments, and events posted on calendar take precedence over range access. KAC Membership does not include JOAD & AAP benefits.

**Junior Olympic Archery Development (JOAD) & Adult Archery Program (AAP) Membership:** JOAD and AAP are archery programs where archers earn star pins for skill levels. All JOAD & AAP members must be Youth, Adult, Collegiate, Family, or Lifetime members of USA Archery to be eligible. Recreational USA Archery members are not eligible to join JOAD & AAP. JOAD & AAP membership does not include gate code access. The membership fees are in addition to the KAC membership fee and are not prorated.

**Fees:** Outdoor session and indoor session **RANGE FEES is \$5** per person for members and non-members. **EQUIPMENT RENTAL is \$5** per person (if needed) to both members and non-members during supervised range hours. \$5 to rent any or all equipment.

**Guests:** Guests may shoot on the outdoor club range on two (2) separate occasions while accompanied by a current member. Then the guest must take the Orientation and then become a KAC member to shoot at the range. All guests must sign the KAC and USA Archery waivers before shooting.

2. I FULLY UNDERSTAND that archery activities involve risks and dangers of BODILY INJURY, INCLUDING PERMANENT OR PARTIAL DISABILITY, PARALYSIS, OR DEATH OR OTHER HARM ("Risks").
3. I hereby agree that as organizer of this event I have/will use due diligence to ensure the archery range is secured and safe to avoid potential injury to participants and spectators and to avoid potential harm to the facility. # Welcome to Kennesaw Archery Club

## Frequently asked questions:

**Can I leave my minor child at the field? No.** For your child's safety, a parent or (18 years or older) guardian must be present anytime a minor is at the range. If a driving age minor has driven to the field, they do not need a parent or guardian present. There is no exception to this safety rule!

**Can I stand on the shooting line or walk to the target with my child? No.** Only certified members of Kennesaw Archery are allowed at or beyond the shooting line. To join your child you will need to take the orientation class and become a USA Archery member, as well as pay the \$5 range fee. There is no exception to this safety rule!

**Can I coach my child from the sidelines? NO!** Leave the coaching to the coaches

**Can I walk down with my child to retrieve arrows? NO!** Only certified members of Kennesaw Archery are allowed past the shooting line on Saturday sessions or special events.

**Is there a dress code? YES.** Shoes must cover entire foot (no sandals, crocks, etc.). Shorts must be longer than finger-tip length. Shirts for both males and females must be modest in style (no camisoles, shirts that show mid-drifts, or shirts with cut off sleeves or cut out sides).

**Do I need to become a member of USA Archery? Yes.** All archers, both KAC members and non-members must become members of USA Archery by their 4th visit to the range. The USA Archery membership can be completed through the USA Archery website -- [www.teamusa.org/USA-Archery/Membership](http://www.teamusa.org/USA-Archery/Membership). Please select Kennesaw Archery as your club affiliation. Kennesaw Archery Club Members and non-member archers must be Recreational, Youth, Adult, Family, or Lifetime USA Archery members. **JOAD and AAP (SOAD) Members** must be Youth, Adult, Family, Collegiate or Lifetime members of USA Archery to be eligible to earn JOAD or AAP Star Pins. USA Archery Recreational member are not eligible to earn JOAD or AAP Star Pins.

**Can I upgrade my USA Archery membership? Yes.** However, it cannot be done online and is a mail-in process. Our advice is to join as an adult or youth if you think that you might be interested in joining JOAD or AAP or participating in competitions.

**Do I need to attend the KAC orientation session before I can use the field or attend lessons? Yes.** All must attend. Archers learn the basics needed to begin lessons. More importantly, the archers learn about range and archery safety. Class size is limited, so sign up early.

**Do you accept "walk-ins" for orientation sessions? No.** Because of limited space, we do not accept walk-ins for orientation.

**Do I need to be a KAC member to attend sessions? No.** However, you will need to be a USA Archery member.

**How do I get on the Kennesaw Archery Club email list?** After taking an orientation or joining KAC you will be added to the email list. KAC sends out emails weekly regarding the upcoming sessions and activities. We may send out an additional email with important announcements such as membership information, range announcements, or tournament information. We do not share your email with club members or share you email address to any outside organization.

**Do I need to sign the KAC, NFAA and the USA Archery waivers each membership year? Yes.** The USA Archery, NFAA waivers and the Kennesaw Archery waiver and Photo Release form are valid July 1 thru June 30 each membership year.

**Do you accept credit cards? Yes.** We accept cash (exact change please) and checks. KAC will charge \$25 + check value for returned checks. There will be a small convenience fee attached to a credit card transaction.

**What are JOAD and AAP?** Junior Olympic Archery Development (JOAD) and Adult Archery Program (AAP) are goal orientated award programs. Youth and adults earn star pins for reaching set score goals at set distances. You will notice many archers with these award lanyards on their quivers at the field or at competitions. You need to be a Youth, Adult, Family, Collegiate or Lifetime USA Archery member and a member of the KAC JOAD/AAP program to be eligible to earn star pins.

### What do I need to do to become a member of Kennesaw Archery Club, AAP, or JOAD?

1. Take the KAC Orientation
2. Join USA Archery (Copy of your USA Archery membership card must be provided with your application.)
3. Completed membership application
4. Completed KAC Waiver with Photo Release form
5. Completed USA and NFAA Waiver
6. Payment (including Cobb County per person fees)

**Who needs to pay the Cobb County Parks and Recreation Fee?** All KAC members must pay the per person fee. The CCPR department charges a \$10 per person fee for all Cobb County residents and a \$15 per person fee for non-Cobb County residents for use of Cobb County property.

**When will I receive my membership card and gate code to the outdoor range?** Once the 6 items that are listed above have been received and your county address has been verified, the KAC membership card with the gate code will be given to you at the field. If you are applying by mail, your membership card and the gate code will be emailed to you. Please keep card on you while at the range to prove your membership in the Club.

**Do I receive the gate code if I am only a JOAD or AAP (SOAD) member? No.** You must be a full Kennesaw Archery Club member to receive the gate code.

**Can my membership be prorated since I am joining late in the membership year? Yes and No.** The KAC membership fee can be prorated. The Cobb County, the AAP membership, and the JOAD membership fees cannot be prorated.

**Is rental equipment available? How much are sessions?** Equipment is available for rental during scheduled session hours. There is a \$5 per visit for any equipment rental fee. An additional fee of \$5 for the range.
